**MDRRMC RESOLUTION NO. 01-2022  
SERIES OF 2022**

**RESOLUTION REQUESTING FINANCIAL ASSISTANCE NEEDED FOR IMMEDIATE RECOVERY AND REHABILITATION FROM THE EFFECTS AND DAMAGES DUE TO TYPHOON ODETTE IN THE MUNICIPALITY OF ALEGRIA, SURIGAO DEL NORTE**

**WHEREAS**, the Municipality of Alegria, Surigao del Norte was seriously under state of calamity due to Typhoon Odette, which hit the municipality on December 16, 2021. The Municipality issued Sangguniang Bayan Resolution No. 2021-129 series of 2021 dated December 20, 2021, adopting the MDRRMC Resolution No. 22-2021 dated December 17, 2021;

**WHEREAS**, based on the Disaster Response Operations Monitoring and Information Center (DROMIC) as of January 7, 2022, the MSWDO posted **6,500 total Number of Affected Families** during Typhoon Odette.

**WHEREAS**, the MSWDO DROMIC reported a total of **3,496 damaged houses** of severely affected population composed of 490 totally damaged houses and 3,006 partially damaged houses;

**WHEREAS**, based on the damage report from the Municipal Agriculture Office as of December 27, 2021, and as stated in the Post Disaster Needs Assessment (PDNA), the Municipality has a total estimated damage of agriculture amounting to **₱215,053,025.00**;

**WHEREAS**, the PDNA and based on the Municipal Engineering Office report, there is a total estimated damage in infrastructure of **₱93,450,000.00** for government building only;

**WHEREAS**, the Municipality received only ₱3,842,000.00 Shares from the Additional Financial Assistance for Local Government Units Hit by Typhoon Odette Charged Against the FY 2021 Unprogrammed Appropriations, and financial assistance of ₱1,080,518.00 from the Office of the President and ₱100,000.00 from the Landbank of the Philippines, which are not enough to provide the needed urgent financial assistance to severely affected population in the municipality;

**WHEREAS**, the Municipality is only 5<sup>th</sup> Class Local Government Unit that has very limited resources especially on financial matters and is highly dependent on National Tax Allocation; hence the Municipality relies on the financial needs from the National Government;

**WHEREAS**, upon the consultation and thorough discussion with the members of MDRRMC together with the Punong Barangays and Barangay Secretaries gathered on a meeting, this Council find it very essential that huge amount of financial resources be immediately allotted for the recovery and rehabilitation programs to restore the municipality and its communities from the impacts and losses brought by Typhoon Odette;

**WHEREFORE, BE IT RESOLVED** as it is hereby resolved to **request financial assistance needed for immediate recovery and rehabilitation from the effects and damages due to Typhoon Odette in the Municipality of Alegria, Surigao Del Norte.**

**FURTHERMORE RESOLVED**, that copy of this Resolution be furnished to the Sangguniang Bayan of Alegria, Surigao del Norte, Department of Social Welfare and Development (DSWD), Department of Budget and Management (DBM), Department of Interior and Local Government (DILG), Office of Civil Defense, National Housing Authority (NHA), Department Works and Highways (DPWH), Provincial Government of Surigao del Norte, and all concerned offices and organizations for appropriate information, immediate and compassionate action.

**ADOPTED THIS 7<sup>th</sup>** day of January 2022 on the motion of Municipal Engineer Roco G. Moca and duly seconded by mass.
